## **EDUCATIONAL TIP OF THE WEEK**

## TIMES TABLES TRICKS: The 9's

Use this to help your child with products for tricky 9's:

**Step One:** Look at the equation. Point to the number that is NOT the 9. For example, in the equation  $9\times4=$ \_\_\_, point to the 4.

**Step Two:** Subtract 1 from the number that you are pointing to. In this example, you would think "4-1=3." The difference (in this case, 3) will be the first number of your product. So now our equation looks like this:  $9\times4=3$ \_\_.

Step 3: When you add the numbers in the product together, they will make 9. So now we need to think, "What can I add to 3 to make 9?" In this case the answer is 6. Add this 6 as the second digit in your product: 9×4=36.

And there you have it!





#### Support Fine Arts, Athletics, and Enrichment at Calibre Academy!

You can support Calibre Academy and receive a dollar-for-dollar state tax credit. Pick an extra-curricular activity to support and 100% of your donation goes to the activity of your choice.

#### What is a tax credit?

Arizona Law (ARS 43-1089.01) allows married couples filing jointly a tax credit of up to \$400 and individual taxpayers a tax credit of up to \$200 when they contribute to extra-curricular activities in public schools. This tax credit is available to all who reside in Arizona and have a tax liability at least equal to that of their donation. You do not have to be a parent of a child at Calibre Academy to benefit from this law. Corporations are not eligible. Contributions are donated directly to the schools. This means your donations are used directly to support student activities at Calibre Academy of your choice. Donations may be submitted through April 15, 2018.

To claim the tax credit, taxpayers must contribute to an extra-curricular activity for which the school district requires a fee or funds to operate the program. Extra-curricular activities are optional, noncredit educational activities that are offered before, during or after school hours. Examples include enrichment activities, athletic and music programs, and after school clubs. These programs depend on fees from students. The Governing Board has approved a fee schedule, which designates the appropriate extra-curricular programs.

#### How do I receive my tax credit?

Please do the following if you would like to receive the tax credit:

- Complete the Arizona Tax Credit Contribution form. Attach your check made payable to Calibre Academy.
- Indicate on the response form how you would like your donation to be used. If you have no preference, you may choose the category school may designate use.
- Upon payment, a pre-numbered receipt will be given or mailed to you for tax reporting purposes. Please place this form with your other tax preparation documents.
